# CAPTIONS AVAILABLE TO ALL ZOOM USERS—A BIG LEAP FOR ACCESSIBILITY

Zoom has announced that they are making automated captions more accessible than ever, rolling this out to all users in phases by the end of September. This means that the "CC" button will now appear automatically in Zoom Meetings—no host or admin intervention required. This accessibility update ensures that users who are deaf or hard of hearing can engage more fully and independently during meetings. Along with this automatic activation comes a refined captioning experience: you can now personalize captions with options like font size, color, placement, and layout to suit your needs better.

#### Improved Quality, More Languages, and Smarter Al

This update also brings enhancements in transcription quality via Zoom's updated Speech AI—making captions more accurate even in noisy environments or when complex terminology is used. The platform now supports real-time translation in over 36 languages alongside improved bilingual caption models—including a new Arabic/English pairing. Zoom is also introducing on-device processing for captions, helping ensure they remain fast and reliable, especially when your connection is inconsistent.

#### **Why This Matters**

For many in the deaf and hard-of-hearing community, captions are more than an accessibility feature—they are a gateway to meaningful participation. These latest improvements make captioning automatic, adaptable, and higher quality, reducing barriers to communication in both social and professional settings. With language options expanding alongside smarter AI and enhanced customizations, users can now engage in virtual conversations with greater confidence and comfort.

Captions will be enabled for all of our meetings. If you joined our meeting to access captions from the Meetings app or in a full-featured meeting:

- 1. Click on the CC icon on the lower left of your screen or
- 2. From the Webex App, tap More options > Closed Captions > View Captions and Highlights

# **ALLY'S ACT (H.R. 4606)**

A critical insurance coverage gap for specialized hearing implant devices affects around 500,000 children and adults in the U.S. with congenital conditions like microtia and aural atresia, or who experience sudden hearing loss from illness or trauma. Ally's Act was introduced as H.R. 4606 in the 119th Congress (2025–2026) by Rep. Joe Neguse (D–CO). You can help close this gap by supporting Ally's Act (H.R. 4606), which would require coverage for medically necessary hearing devices. Ally's Act was inspired by the story of Ally, a young girl born without a right ear or ear canal, who was denied insurance for a bone-anchored hearing aid (BAHA).

# WHY INDUCTION STOVES MAY CAUSE BUZZING IN HEARING DEVICES

Induction cooktops generate strong electromagnetic fields to heat cookware, which in some cases can cause buzzing, humming, or temporary sound distortion in hearing aids or cochlear implants when users are very close to the active surface. These stoves operate by producing rapidly alternating magnetic fields that induce electric currents in compatible pots and pans. However, the same fields can sometimes be picked up unintentionally by the microphones, telecoils, or sensitive circuitry of hearing devices. This can create audible interference that is distracting or reduces speech clarity in the kitchen. Although generally harmless to the function of hearing aids or cochlear implants, maintaining a safe distance from an active cooktop or adjusting device settings often minimizes the impact of interference.

Medical professionals and members of the hearing loss community are invited to attend.


# BRINGING THE PATIENT VOICE INTO AUDIOLOGY EDUCATION
